#### **NEW BUSINESS:**

## 1. <u>Discussion and/or Motion Items:</u>

a. Commissioner Fitzgerald made a motion to approve the request for a driveway extension from William Hess. Commissioner Hedrington second the motion. Council discussed the request for a driveway extension. Council was provided with 3 options which included Mr. Hess's request, what is allowed under the current code, and what Staff recommended as a compromise. Attorney Sosnowski reviewed the options with Council and explained Mr. Hess is requesting an extension that is outside of what the current code allows. Attorney Sosnowski reviewed all 3 options. Zoning Official, Jessica Roberts said Staff has been crafting new language regarding driveways to bring to Council for review and approval, however; until the code is changed these types of requests may come up again. Staff will need to know what Council will approve going forward. Commissioner Duffy expressed concern with driveway standards going forward. After discussion and review, Commissioner Fitzgerald made a motion to approve the staff
