Per Section 86-190(f), for any portions of a parking lot entrance driveway that are in the right-of-way, the curb cut width and all geometrics of all driveways within the right-of-way shall be in accordance with the current IDOT bureau of local roads and streets standards for driveway and entrance geometrics, on file in the office of the City Clerk.

Per Section 86-401(3) Surety Required

A performance bond, letter of credit or other form of surety acceptable to the City, equal to 120% of the estimated costs of the work within the public right-of-way must be filed with the City Clerk if any work is to be done in the public right-of-way

Per Section 86-401(6), Any persons with a parking lot that abuts a federal, state or county roadway must obtain the proper agency review prior to receiving a permit from the City.

Per Section 86-402 Composition

Parking lots must meet all composition requirements as listed in Section 86-402.

All parking lots must meet all zoning requirements, including but not limited to, the requirements in Section 118-343 Additional regulations; parking.
