- a. Commissioner Morse made a motion to approve Ordinance <u>2725</u> amending Section 14-101 Adopting the 2021 version of the International Property Maintenance Code. Commissioner Prentice second the motion. Roll call vote showed 5 ayes.
- b. Commissioner Hedrington made a motion to approve the first read of Ordinance 2726 approving a Zoning Variation in the side yard setback from the required 5' setback down to 0', and the required 30' front yard setback down to 25' in the (RM) Residential Multi-family Zoning District for the property located at 15528 Lucena Court, South Beloit, Illinois, Winnebago County, PIN No. 04-04-377-011. Commissioner Adleman second the motion. Attorney Sosnowski asked the item be moved to the 2nd read since the item went to the Zoning Board of Appeals (ZBA) in November. Commissioner Prentice made a motion to waive and move the item to the second read. Commissioner Adleman second the motion. Voice vote carried the motion. Attorney Sosnowski said the ordinance is for the front yard setback only, not the side yard setback. The side yard setback was postponed by the ZBA until the parcel is split. Commissioner Hedrington made a motion to approve Ordinance 2726 second by Commissioner Prentice. Roll call vote showed 5 ayes.

RESOLUTIONS:

- a. Commissioner Adleman made a motion to approve Resolution <u>6405</u> approving and authorizing the Mayor to sign a Joint Engineering Contract between the Village of Roscoe, the City of South Beloit and Fehr Graham. Commissioner Morse second the motion. Roll call vote showed 5 ayes.
- b. Commissioner Adleman made a motion to approve Resolution <u>6406</u> in support of Tax Increment Financing. Commissioner Prentice second the motion. Roll call vote showed 5 ayes.
- c. Commissioner Morse made a motion to approve Resolution <u>6407</u> retroactively approving a Indemnification Agreement with Sauk Valley Community College Police Academy for Stephen Hogan to attend the Police Academy. Commissioner Hedrington second the motion. Roll call vote showed 5 ayes.
- d. Commissioner Prentice made a motion to approve Resolution <u>6408</u> approving a Uniform Grant Agreement (UGA) with the Illinois State Police for the Violent Crime Intelligent Task Force. Commissioner Adleman second the motion. Roll call vote showed 5 ayes.
- e. Commissioner Morse made a motion to approve Resolution <u>6409</u> authorizing the purchase of a 2024 Ford Horton Ambulance at a cost of \$361,053.00. Commissioner Adleman second the motion. Fire Chief Griffin said the price is only for the ambulance, which does not include a new cot, radios, and other equipment. Roll call vote showed 5 ayes.
- f. Commissioner Adleman made a motion to amend Resolution <u>6410</u> amount from \$99,000.00 to \$99,010.00. Commissioner Prentice second the motion. Voice vote carried the motion. Commissioner Hedrington made a motion to approve Resolution <u>6410</u> to award an Annual Audit Contract to Lauterbach & Amen, LLP to perform the Annual Audit for Fiscal Years 2022, 2023, and 2024 not to exceed \$99,010.00. Commissioner Adleman second the motion. Roll call vote showed 5 ayes.

- a. Commissioner Morse made a motion to approve appointing Joanna Harris as FOIA
 Officer for the Police Department. Commissioner Hedrington seconded the motion.
