APPROVE AGENDA:

ORDINANCES-SECOND READ:

- a. Commissioner Morse made a motion to approve Ordinance 2727 an Amendment to the phased pavement timeline conditions of the Special Use Permit granted by the City of South Beloit pursuant to Ordinance number 2382 which allows for automobile repairing, overhauling, rebuilding, and painting for used car prep including mechanical and cosmetic repairs for Clancy's Auto Sales in the Industrial Light (IL) Zoning District for the property located at 1020 Gardner Street, Building B, South Beloit, Illinois, Winnebago County for part of PIN No. 04-05-420-105. Commissioner Hedrington second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.
- b. Commissioner Hedrington made a motion to approve Ordinance 2728 an Amendment to the phased pavement timeline conditions of the Special Use Permit granted by the City of South Beloit pursuant to Ordinance number 2383 which allows for auto uses (towing company, office, and towed vehicle storage) with accessory outdoor storage of items and materials accessory to primary use limited to no more than 25 percent of the total lot area, to be located within the rear yard, and subject to screening from view of adjacent properties by a combination of landscaping and fencing for Flying AJ's Towing in the Industrial Light (IL) Zoning District for the property located at 1020 Gardner Street, Building A, South Beloit, Illinois, Winnebago County for part of PIN No. 04-05-420-105. Commissioner Morse second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.
- c. Commissioner Hedrington made a motion to approve Ordinance <u>2730</u> amending Section 6-82 of the Liquor Code creating a Class WS License. Administrator Hoppes said her, and the City Clerk reviewed all current Liquor License fees. Their recommendation for the cost of the license fee is \$500.00. Commissioner Hedrington second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.

ORDINANCES-FIRST READ:

- a. Commissioner Morse made a motion to approve the first read of Ordinance 2732 approving a revised Towing Policy for the City of South Beloit. Commissioner Hedrington second the motion. Chief Truman explained tow companies have asked for an increase in their standard tow rate from \$150.00 per tow to \$250.00 per tow. Commissioner Hedrington second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.
- b. Commissioner Adleman made a motion to approve the first read of Ordinance 2733 amending Chapter 106 Utilities, Article III Sewers and Sewage Disposal, Division 4 Service Charges, Section 106-166, of the City of South Beloit Code of Ordinances to allow businesses to apply for account adjustments due to Catastrophic Water Loss events. Commissioner Morse second the motion. Administrator Hoppes said the city has a business that may want to apply for the loss if the ordinance is passed. Commissioner Adleman made a motion to move to the second read and approve Ordinance 2733. Commissioner Hedrington second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.

- a. Commissioner Adleman made a motion to approve Resolution <u>6421</u> accepting a grant from the Illinois Housing Development Authority's Home Repair and Accessibility Program. Commissioner Morse second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.
- b. Commissioner Hedrington made a motion to approve Resolution <u>6422</u> authorizing and approving a proposal from Motorola Solutions, Inc. for the purchase of radio equipment for the Fire Department at a cost not to exceed \$159,803.86.
 Commissioner Morse second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.

- c. Commissioner Morse made a motion to approve Resolution <u>6423</u> authorizing the City to approve a Copy Machine Lease Agreement with Impact Networking for a copy machine for the Fire Department. Commissioner Adleman second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.
- d. Commissioner Hedrington made a motion to approve Resolution <u>6424</u> authorizing the sale of 317 Burr Oak. Commissioner Adleman second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Prentice.
