ORDINANCES-FIRST READ:

- a. Commissioner Morse made a motion to approve the first read of Ordinance <u>2758</u> amending Section 50-5 of the Code of Ordinances regarding Fingerprinting.
 Commissioner Prentice second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Adleman.
- b. Commissioner Morse made a motion to move Ordinance 2759 to the Zoning Board of Appeals prior to Council's approval. Commissioner Prentice second the motion. Attorney Sosnowski said the item would appear as a text amendment to the Zoning Code and would require a Public Hearing with any comments. Attorney Sosnowski reviewed the ordinance. Commissioner Prentice said he had issue with the requirement for hard wiring electrical instead of extension cords and consent from adjacent property owners. Commissioner Prentice said the requirement for hard wiring electricity would be the most expensive item for having chickens. Mayor Fitzgerald agreed with both issues of concerns from Commissioner Prentice. Input was provided by WWTP Superintendent, Jeff Reininger as a farmer what his opinion on the electrical requirements and stated that the outlets cause issues due to moisture and corrosion. Attorney Sosnowski said staff time and Code Enforcement policing were the reasoning regarding the adjacent property owners consent as there will likely be issues between neighbors. Commissioner Prentice said he felt it was no different than having a swimming pool since the noise is sometimes an issue between neighbors. Administrator Hoppes said the draft of the ordinance was based off the feedback from all 5 council members. Administrator Hoppes said when she called each council member for input Commissioner Adleman had asked for the electrical wiring as a precaution for fires. Commissioner Morse asked Fire Chief, Jason Griffin if the extension cords would be a hazard. Chief Griffin said extension cords are not allowed in businesses due to causing a fire hazard. The fire department would have no control over residential inspections as this would fall under the Code Enforcement department. Chief Griffin said he has seen instances where a chicken coop has caught fire from the heater. Commissioner Morse said he has seen a home burnt down due to Halloween decorations that were run from extension cords. Commissioner Hedrington said he did not believe he would be in favor of the ordinance to allow chickens. Attorney Sosnowski suggested Community Director Henthorn contact the Winnebago County Building Department Building Manager, Steve Girard and Fire Inspector, Jim Griffin for input and send out notes to council. The draft can remain the as is when the item goes to the Zoning Board of Appeals. Consensus was to follow the recommendations from Attorney Sosnowski. Voice vote carried the motion to forward the item to the Zoning Board of Appeals.
