Commissioner Morse second the motion. Commissioner Prentice made a motion to waive the second read. Commissioner Adleman second the motion. Roll call vote showed 5 ayes.
- e. Commissioner Adleman made a motion to approve Ordinance <u>2712</u> Amending Chapter 6 Alcoholic Beverages, Article III, Retail Licenses, Section 6-82, of the City of South Beloit Code of Ordinances to limit the number of "BG" Licenses within the City. Commissioner Prentice second the motion. Commissioner Adleman said the item was previously discussed at the last Regular Council Meeting. Commissioner Adleman recommended capping the number of licenses to 11. Roll call vote showed 3 ayes and 2 nays by Commissioner Hedrington and Mayor Fitzgerald.
- f. Commissioner Adleman made a motion to approve Ordinance <u>2713</u> approving a Class D Liquor License for B & B Tobacco Inc. Commissioner Morse second the motion. Commissioner Adleman made a motion to waive the second read. Commissioner Morse second the motion. Voice vote carried the motion. Commissioner Morse made a motion to approve the Ordinance as stated second by Commissioner Adleman. Roll call vote showed 4 ayes and 1 abstain by Commissioner Prentice.

Commissioner Adleman made a motion to approve Resolution <u>6367</u> approving and authorizing the City Administrator to sign a proposal for an IEPA Project Plan for Class A Sludge Handling Equipment, Lift Station One, and the Force Main under the Rock River with Fehr Graham. Commissioner Morse second the motion. City Engineer, Brandon Boggs said the plan is needed to get any grant funding. Roll call vote showed 5 ayes.
- c. Commissioner Hedrington made a motion to approve Resolution <u>6368</u> approving an addendum to the Intergovernmental Agreement with the Illinois State Police for the City of South Beloit to join the Violent Crimes Intelligence Task Force. Commissioner Morse second the motion. Roll call vote showed 5 ayes.
