Attorney Ray Ferguson and Curtis Tillman were present regarding the request. Attorney Ferguson explained the location would be used for 1-2 years for parking of up to 200 trucks with very low volume and low impact. Council discussed the request and the Zoning Board of Appeals recommendation. Commissioner LaMendola made a motion to approve Ordinance 2126 Approving a Special Use Permit for to allow truck storage and open sales lot in the (CG) Commercial General District for the property located at 14339 Willowbrook Road, South Beloit, Illinois, Winnebago County, PIN No. 04-15-100-014 from petitioner Nyman Properties, LLC. Commissioner Baden second the motion. Roll call showed 4 nays and 1 absent by Mayor Schoonover. Motion failed.
- b. From the Zoning Board of Appeals meeting held on November 12, 2014 a positive recommendation was given regarding a request for a Special Use Permit. Commissioner LaMendola made a motion to approve Ordinance 2127 Approving a Special Use Permit to allow for an electronic graphic display sign in the (CR) Commercial Retail Zoning District for the property located at 620 Blackhawk Blvd., South Beloit, Illinois, Winnebago County, PIN No, 04-05-308-001 from petitioner St. Peter Church. Commissioner Baden second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Schoonover.
- c. Commissioner Barber made a motion to approve Resolution <u>5742</u> authorizing the Mayor to execute a Snow Removal Contract for Year 2014-2015 with AMS Asphalt Maintenance Systems Inc. Commissioner Baden second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Schoonover.
- d. Commissioner LaMendola made a motion to approve Ordinance 2122 Amending Chapter 18 of the City of South Beloit Code of Ordinances Revising License Fee and Application Regulations for Tattoo Establishments within the City removing the restrictions of the number of feet allowed for operation. Commissioner Barber second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Schoonover.
- e. Commissioner LaMendola made a motion to approve Ordinance <u>2123</u> Authorizing the Establishment of Interested Parties Registries and adopting rules for such registries for redevelopment project areas in the City of South Beloit regarding the Gardner/Blackhawk "TIF". Commissioner Barber second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Schoonover.
- f. Commissioner LaMendola made a motion to layover Ordinance <u>2124</u> Authorizing the disposal of personal property owned by the City of South Beloit until the next Regular Meeting. Commissioner Baden second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Schoonover.

- g. Commissioner LaMendola made a motion to approve Resolution <u>5743</u>to approve the purchase of one 2014 Ford Police Interceptor SUV from Currie Motors with corresponding emergency equipment from Ultra Strobe., Eby Graphics, and Watchguard at a cost not to exceed \$38,415.38. Commissioner LaMendola made a motion to amend Resolution <u>5743</u> to revise the year of the Ford Police Interceptor SUV from a 2014 to a 2015. Commissioner Baden second the motion.
