City Clerk, Tracy Patrick informed Council that this request was for the Police Department and that this request took approximately 8 hours between Attorney Sosnowski and the Police Department.

## UNFINISHED BUSINESS:

Commissioner Barber made a motion to approve the bid recommendation from McMahon Engineering from Larson & Larson Builders in the amount of \$46,750.00. The City received a grant in the amount of \$40,000.00 for this project. The engineering budget was approximately \$5,900.00, which leaves an amount of \$12,650.00 the City would have to put in for the project. Commissioner LaMendola second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner LaMendola made a motion to approve Ordinance <u>1960</u> Authorizing the City of South Beloit to borrow funds from the Water Pollution Control Loan Program for the purpose of constructing repairs to the sanitary sewer system. The loan would be in the amount of \$900,000.00. Commissioner Barber second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner LaMendola made a motion to approve Ordinance <u>1954</u> Approving a Text Amendment to the City of South Beloit Zoning Code regarding Electronic Graphic Display Signage. Commissioner Chambers second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

## **NEW BUSINESS:**

Commissioner LaMendola made a motion to approve the request for a sign on Blackhawk & Gardner fence from The Wheel for a Luau for Jason event to be held on August 31, 2013. It was noted that the timeframe per the City's Code allows for a sign to be up for a period of 3 weeks. Commissioner Chambers second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner LaMendola made a motion to approve the request for a sign on Blackhawk & Gardner fence from Cranked Inc. for a Toy Drive to be held on October 15, 2013. Commissioner Barber second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner Barber made a motion to approve the request for a sign on Blackhawk & Gardner fence from The Planning Committee for the Lori Daniels Hope for Justice Scholarship fundraiser to be held on October 11, 2013. Commissioner LaMendola second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner LaMendola made a motion to approve the request for a sign on Blackhawk & Gardner fence from the Wheel for a Moonlight Bowl to be held on November 2, 2013 to raise funds for the South Beloit Police Department's Shop with a Cop event. Commissioner Chambers second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

The request for a reimbursement of fees paid to the City for Liquor License, Miscellaneous License, and Video Gaming License from Tads Sport Bar & Grill died for a lack of a motion.

Commissioner Chambers made a motion to approve the hiring of Adam Reed as a paid on call Fireman for the Fire Department effective August 19, 2013. Commissioner Barber second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner Barber made a motion to layover Park Street quotes for drainage improvements. Commissioner Chambers second the motion. Direction was given to City Engineer, Nick Arps to put the project out for bids. Voice vote carried the motion.

Commissioner Barber made a motion to approve Ordinance <u>1961</u> Reducing the Speed limit on South Bluff Road to 35 mph. Commissioner Barber second the motion. Roll call vote showed 4 ayes and 1 absent by Mayor Duffy.

Commissioner Chambers made a motion to layover Ordinance 1962 Amending Chapter 6 Alcoholic Beverages Section 6-82 of the South Beloit Code of Ordinance related to Classification of Licenses adding "BG" Bar Boutique Gaming Liquor License.
